## APPLICATION FOR NJFCC HONORS

#### **GENERAL INFORMATION**

The New Jersey Federation of Camera Clubs has caused the establishment of a form of public recognition of individual contributions to the advancement of the art and science of photography and has directed that the honor be known as the New Jersey Federation of Camera Club Citation for the Advancement of Photography. The award takes the form of an individually written citation and is to be accompanied by a lapel button or pin to be worn by the recipient.

The Citation is to be awarded in recognition of the individual's contribution in one of two categories, but only one citation will be given to anyone individual.

- 1. Those who directly through the agencies or channels of the Federation and/or the affiliated camera clubs have contributed substantially to the advancement of photography.
- 2. Those who may contribute to the advancement of photography without regard to Federation affiliations.

For consideration the individual's contribution should have been made with some direct bearing on the State of New Jersey, either by a resident of New Jersey or one whose principal photographic work is or has been done in New Jersey or of direct benefit to photography in the State. The qualifying contribution need not have been made within any specified period of time, but may have been made over a long period, even a lifetime.

The Federation notes that photography includes a number of areas of endeavor, such as those in which pictures are produced, research and development of equipment and processes, organization and promotion, education and many others. Proficiency and service to photography, both generally and with specific bearing on Federation and member club activities will receive due consideration in the awarding of this Citation. The honors committee may, in its discretion, waive or change requirements when in its judgment the best interests of the Federation and photography in the state will be served.

# APPLICATIONS:

- 1.\* Must be on forms supplied by the Federation.
- 2.\* The deadline for applications to be received by the Honors for the 2017-18 year is: March 25, 2018.
- 3. Applications received after the deadline will be discarded and must be resubmitted to be considered the following year.
- 4. <u>If, in the opinion of the Honors Committee, an application does not contain sufficient information to properly evaluate the achievements of the candidate, or the form is improperly completed, the application shall be returned to the proposer for resubmission.</u>
- 5. All information supplied in completing the application must be factual. The use of flattery, exaggeration or form of language designed to dress up the application are to be avoided. It is particularly important to STATE THE FACTS and to STATE THEM CLEARLY AND IN A PRECISE MANNER.

# PROPOSERS:

- 1. Any member of the Federation, in good standing, may initiate the application.
- 2. It will be the responsibility of the proposer; to carefully read the instructions contained in these pages and the application form and to prepare the required forms accordingly.
- 3. The proposer should weigh carefully the contribution made by the person to be proposed.
- 4.\* It is requested that proposers make this applications without the knowledge of the person being proposed.
- 5.\* Proposers should have the permission of an endorser to use their name for the purpose of an endorsement.
